Section 7 and Section 8 Information

(a) Nonprofit Legal Status. Creekside Pay It Forward. is a North Carolina non-profit public benefit corporation, recognized under North Carolina laws is organized to provide Charitable Purposes by providing an organization for Community Support in times of need or personal crisis.

This is comprised of a network that will utilize the expertise, compassion, and support of the Creekside at Bethpage 55+ neighborhood residents including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Sections 501(c)(3) and 170(c)(2) of he Internal Revenue Code of 1986 (herein the "Code") (or the corresponding provisions of any future United States Internal Revenue Code).

- (b) Exempt Activities Limitation. Notwithstanding any other provision of these Bylaws, no director, officer, employee, member, or representative of this corporation shall take any action or carry on any activity by or on behalf of the corporation not permitted to be taken or carried on by an organization as it now exists or may be amended.
- (c) Prohibited Activities No Part of the net earnings of the corporation shall inure to the benefit of or be distributable to, its members, directors, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments or distributions in furtherance of purposes set forth in these articles of Incorporation.

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carryon any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Code or (b) by a corporation, contribution to which are deductable under section 170(c)(2) of the Code.

(d) Distribution Upon Dissolution. Upon termination or dissolution of the Creekside Pay It Forward., any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the 1986 Internal Revenue Code (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

Any such assets not so disposed of shall be disposed of b the Superior Court of Durham County, North Carolina, exclusively for such purposes or to such organizations, or to such governments for such purposes
